# Supplier Shipments North American Inbound Routing Guide

Effective: March 23<sup>rd</sup>, 2023 (Supersedes routing guide of 1/23/2023)

Shipments from International locations, including Canada and Mexico, must contact Import Export Long Beach office at 631-812-6022 for Shipping and Routing Instructions.

#### To our valued suppliers:

The following pages provide routing instructions that must be adhered to when shipping to Leviton Manufacturing locations or on Third Party shipments when Leviton is responsible for the freight charges (freight collect to Leviton).

Part I Small Parcel – Ground and Air up to 300 lbs.

Part II LTL-301 lbs. to 8,000 (less than ¼ trailer or 8 pallets)

Part III Third Party Billing/Drop Ship

Part IV Over 8,000 lbs. (8 pallets or more - ¼ of trailer)
Part V Air Freight – over 300 lbs. – Palletized Freight

Part VI Insurance/Declared Value

#### Part I Small Parcel – Ground or Air

Leviton Manufacturing Company requires you to ship FedEx Bill Recipient or Third Party on all inbound small package shipments; Ground and Air up to an aggregate weight of **300 lbs**.

**Authorized FedEx Services: Ground** 

FedEx Next Day Air - contact buyer for approval FedEx 2nd Day Air - contact buyer for approval

Each individual package must meet FedEx weight and size requirements:

150 Pounds maximum weight per package 165" in length plus girth (L + 2H + 2W) 108 Inches maximum length

Please use our FedEx Bill Recipient (FedEx version of collect) ACCOUNT NUMBER shown on Attachment 1 that corresponds to the plant number you are shipping to ("ShipTo;").

When you begin using this program to ship our small package shipments, you MUST include the Purchase Order number on each package address label and input the PO number in reference field # 1 on the FedEx online system.



### Part II LTL 301 lbs. to 8,000 lbs. (less than ¼ trailer or 8 pallets)

For all shipments exceeding the previous weight limitations for Small Parcel (ground and air) stated above please route per applicable matrix below.

In addition, if your shipment is below 300 lbs but is palletized, please route via LTL carrier per matrix below. Palletized freight cannot be shipped via a parcel carrier.

### Exceptions for Part II and Part III - LTL Freight

**Leviton Manufacturing Co., Inc.** is utilizing Redwood/Simplified Logistics to manage Less-Than-Truckload (LTL) shipments from your location into our facilities. You will be contacted by Leviton Logistics if you need to be set up on the Redwood system. If you are requested to use Redwood, please make sure to utilize Redwood for LTL. Otherwise, please continue to use the routing guide.

## **BOL Exceptions for LTL Freight**

If you are **NOT** able to create a BOL for a shipment on your own, please email Leviton Logistics at logistics supplier@leviton.com

The following information **is required** when contacting Leviton for shipment creation:

- Pickup address
- Ship to address
- Hours of operation for freight pickup
- Number of pallets
- Total Weight
- These are optional: pallet dimension & FAK

The below listed Bill To address **only applies to shipments where Leviton is responsible for paying** the freight. Otherwise, use your account bill to address.

Regardless of carrier, Bills of lading must be marked FREIGHT COLLECT. Bills should be sent via EDI from carrier to Redwood (Simplified).

BOL should show billing address as:

Leviton c/o Simplified Logistics PO Box 40088 Bay Village, OH 44140

and include the Leviton Purchase Order Number; NMFC Item Number; and Class Rating.



**Note:** Expedited / Time Critical Service – Contact buyer for approval.

Leviton PO number(s) is required on the Bill Of Lading. Please fill in the PO Number(s) that you are shipping. Failure to do so will result in processing charges.

#### Carrier Matrix: See Page 5 (Collect) and Page 6 (Third Party)

This matrix applies to inbound shipments from a Leviton Supplier into a Leviton facility. Find your origin state or region. Look up the inbound state/plant or warehouse number to determine the freight carrier. If you are shipping from and to the same state, check type Intrastate

# Part IV Shipments over 8,000 lbs. and/or 200 cubic feet

Call Central Dispatch at 1-800-421-4214 or email logistics\_supplier@leviton.com for routing instructions at least 24 hours in advance.

Part V Air Service - Over 300 lbs. — Palletized Freight Next Day Air or 2<sup>nd</sup> Day Air ONLY Contact buyer for approval.



## Part VI Insurance/Declared Value

Do not insure or declare a value on any shipment. If insurance is requested, the shipper/supplier must pay the carrier. Fees billed to Leviton will be charged back.

## **Part VII Handling Fees**

Handling charges are not approved. These charges will be declined, and a credit required.

# **Part VIII Freight Chargebacks**

These instructions supersede any and all previous routing instructions. Failure to comply will result in chargebacks for the full freight charge billed to Leviton, plus an administrative fee.
