



CONTECH LIGHTING WARRANTY

4-YEAR LIMITED WARRANTY FOR ELECTRONIC TRANSFORMERS

ConTech Lighting warrants to its customer and the original end user that Electronic transformers will be free from manufacturing defects for a period of four (4) years from the date of shipment by ConTech Lighting, except that 60W and 75W transformers carry a three (3) year warranty following the date of shipment to the customer, and the LRT60 carries a one (1) year warranty following the date of shipment to the customer.

ConTech Lighting, at its sole option, will repair, replace, credit or refund, any warranted product returned to it that it determines to be defective. Customer or consumer must return the product, transportation prepaid, to ConTech Lighting at 725 Landwehr Road, Northbrook, IL 60062 within the warranty period. No return of products will be accepted without a Return Goods Authorization ("RGA") which may be obtained by calling 847-559-5550. This warranty excludes and there is disclaimed liability for removal of this product or reinstallation of this product or a replacement product. This warranty is void if this product is installed in violation of the National Electrical Code, or any applicable local electrical codes, or in an improper environment, misused, opened, abused or altered in any manner, or is not used under normal operating conditions, or not in accordance with any labels or instructions. This warranty does not cover damages due to environmental conditions, acts of nature, animal or insect activity, or power surges.

THE ABOVE EXPRESS WARRANTY STATES THE FULL AND COMPLETE OBLIGATION OF CONTECH LIGHTING. ALL IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED IN DURATION TO THE TERM OF THE EXPRESS WARRANTY. THE REMEDIES PROVIDED HEREIN ARE THE EXCLUSIVE REMEDIES UNDER THIS WARRANTY, WHETHER ARISING OUT OF CONTRACT, TORT, STRICT LIABILITY, OR OTHERWISE.
