RE: VerifEye™ Building Manager Online (BMO) 3.0 Software



Discontinuation notice for VerifEye™ Building Manager Online (BMO) 3.0

Leviton is discontinuing version 3.0 of the Building Manager Online software (BMO) and replacing it with the new and upgraded Building Manager Online platform. All existing software part numbers will be discontinued in favor of their new BMO replacements. While the functionality will be very similar, the module options will be changing slightly.

We will continue to offer a base module with the core data collection and reporting features suitable for Code Compliance. For more advanced reporting features, there will be an Advanced Reporting module upgrade. Tenant Billing will continue as a separate module, which will include all of the features of the base module and advanced reporting module.

Where BMO 3.0 software was licensed on a per, or per building basis, the new BMO platform licensing will be entirely based on the total number of metering points. A metering point is defined as each individual data point coming from a meter. A typical pulse meter will use 1 metering point for kWh (consumption) and possibly a 2nd data point for Demand, if needed. Advanced meters (S3500, 4000/4100, 7000/7100, 8000) offer a much broader data set. Each of these individual pieces of data will count as a data point in BMO. Licenses will be based on a total number of data points allowed.

Example:

- 50 Mini Meters – kWh only = 50 data points
- 1 Series 4000 Meter (full data set) = 37 data points (User defines which are activated in BMO)

During configuration, the user will select which points of data are important and only activate the points needed to provide the appropriate reporting. User licenses will be defined by the total number of points which are added in blocks of 50 points.

This will change the structure for total counts for the initial license and for renewals as illustrated in the table below. The current Data Storage renewals are now represented by specific renewal licenses for each module type.

Following is a list of the BMO 3.0 modules and their replacement in the new upgraded BMO platform.*
